Mojay Pots Pty Ltd offers two payment-term options: a) Prepaid – For new accounts and customers with annual spend below \$5000. <ul style="list-style-type: none"> • Payment for all orders must be received prior to packing and dispatch. b) 30 Days – For approved customers with annual spend above \$5000. <ul style="list-style-type: none"> • Payment for all orders must be received within 30 days of invoice date. • Where payment is not received within 30 days of invoice date, Mojay Pots Pty Ltd reserves the right to suspend or cancel 30 Day terms and your account may be changed to Prepaid terms for future orders. • Mojay Pots Pty Ltd retains title of all items delivered until payment has been received. c) Payment methods I.
